



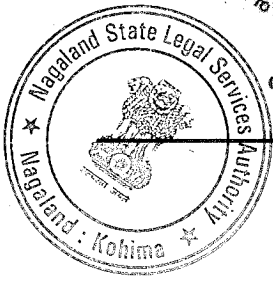

2. Accordingly the revised rate of fixed one day Honorarium payable to the Panel Lawyers & Para-Legal Volunteers is modified as detailed below:

Sl. No.	Group	Existing Rate (Rs.)	Enhanced Rate as per the revision (Rs.)
1.	Panel Lawyers	500/-	800/-
2.	Para Legal Volunteers	250/-	500/-

The revised fixed one day Honorarium is payable and entitled to Panel Lawyers & Para-Legal Volunteers engaged in Legal Services/Aid Programmes as well as for rendering services in the Legal services clinics as mandated under Regulation 17 (1) of the National Legal Services Authority (Legal Services Clinics) Regulations, 2011.
